- 1. Call to Order: President Bardo called the meeting to order @ 6:00 p.m.
- 2. Roll Call: quorum established.

- 4. Public Correspondence: One attendee shared
- 5. Items for Review and Discussion:
 - a. Books for sale are located near the circulation desk. A flyer explains that the cost is \$1.00 per book/media and that the money goes directly back into the library for the purchase of new books.  - c. A rough "plan" of ideas concerning Elcho and White Lake Libraries was addressed. Several people and elected officials from both communities shared and gave input. The Superintendent from Elcho, Rachel Lemanczyk, provided several pictures of the current situation having the public library inside the school building and the safety issues it creates. This is not an ideal setting. The agreement that was signed in 1989 does not reflect today's serious concerns. Toni collected data that described the patrons age and the usage of the library (elderly/ Wi-Fi). The Town Chairman corroborated her information. Offering more programs in Elcho was also a possibility. A motion was made to move forward to the full board meeting a transitioning of services from the Elcho School Library to a mobile unit once a week
